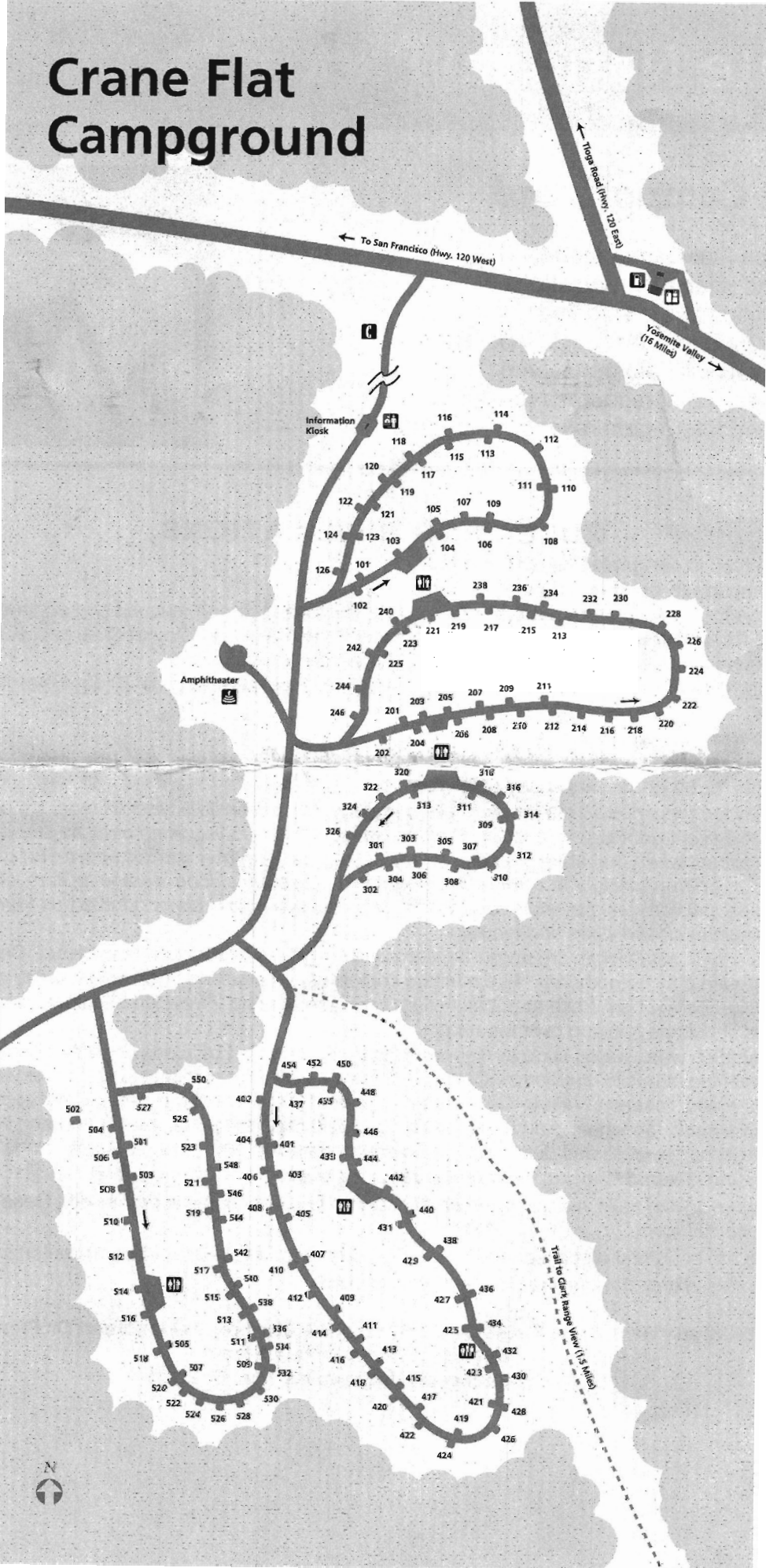


# Crane Flat Campground





## Crane Flat Campground

Welcome to Crane Flat Campground. This list of campground rules and regulations is intended to help you have a safe and enjoyable visit to Yosemite National Park. By observing them, you will help protect the park's natural and cultural resources for future campers and future generations.



### RULES AND REGULATIONS

- ◆ Camping is permitted in designated campsites only.
- ◆ **Six (6) people maximum per site**, including children.
- ◆ **Two motorized vehicles maximum per site.** All vehicles (motorized or not) must be parked on established parking pads designated for each site. Vehicles may not be driven off the roadways. Do not drive past or move rock barriers. Current campground car passes must be displayed in ALL vehicle windshields.
- ◆ **Camping limit** is 14 days inclusive at Crane Flat from May 1 to September 15, and 30 days maximum per calendar year in Yosemite.
- ◆ **Quiet hours are from 10 p.m. to 6 a.m.**
- ◆ **Generator** use is permitted sparingly during daylight hours.
- ◆ **Check out time is 12:00 noon on the day of departure.**
- ◆ **Food Storage:** *All food must be stored properly 24 hours/day. No food in vehicles. All food, ice chests, grocery bags and anything with a scent (toothpaste, deodorant, soap, sunscreen, hairspray, etc.) must be stored in metal food storage lockers, except when preparing or eating meals. **Garbage and litter attract bears and other animals and must be disposed of immediately in dumpsters provided.** Keep metal food storage lockers latched at all times. Hard sided recreational vehicles may store food inside, provided it is not visible or odoriferous from the outside and all doors and windows are closed when unattended.*
- ◆ **Fires:** Build fires only in established fire rings. Do not leave campfires unattended at anytime. Only dead wood already on the ground may be gathered. Fire must be completely extinguished with water so the coals are cold and no smoke is visible. Do not burn trash or put aluminum cans into fire ring. Firewood should fit completely within the fire rings; no logs should be hanging over the ring.
- ◆ **Wastewater:** Camping wastewater, such as dishwater, must be disposed of in proper utility sinks at restrooms. No bathing or dishwashing at public restrooms. Catch basins are needed for sun showers. Sanitary dump stations are located in Wawona and Yosemite Valley. Obtain potable water for RV's at dump stations, not campground faucets.
- ◆ **Pets:** Must be on a leash (no longer than 6 feet) at all times and may not be left unattended and tied to an object. All pet excrement must be removed and disposed of in waste receptacles. Pets are prohibited on hiking trails.
- ◆ **Digging or Leveling Ground:** Digging, leveling, or trenching of the ground is prohibited.
- ◆ **Trees and Shrubs:** Driving nails, stakes, or other objects into trees or shrubs is prohibited. Dead or live trees or shrubs may **not** be cut down.
- ◆ **Bicycling:** Bikes are permitted on paved roads and bike paths only. Bikes are not permitted on trails.
- ◆ Collecting pinecones, rocks, flowers, artifacts, etc. is prohibited.
