

# **Cherry Creek State Park Campground**



We hope you enjoy your stay with us. We are dedicated to your safety and to the preservation of the natural resources of this State Park. Therefore, we ask that you abide by the following Campground Rules. We thank you in advance for your cooperation.

# **Responsible Party**

• The person who's name is on camping permit or reservation is ultimately responsible for campsite.

# Check in/out

 Check in/out time is NOON daily. All camping permits must be renewed by noon or vacated. Use self-service only if the Campground Office is closed.

#### Alcohol

 Maximum of 3.2% alcoholic beverages are allowed. Beverage container will indicate if it contains 3.2%.

# Pets

 All pets must be on a maximum of six-foot leash and under control at all times. Pets may not be left unattended. Pet owners must promptly clean up after pets.

# **Quiet Hours**

• From 10 p. m. to 6 a.m. generators, radios and loud noises must be turned off. This includes voices.

# Parking

- All vehicles must remain entirely on pavement or designated parking area at all times. Do not park on the grass. Parking at all sites is limited to the length of your site. No vehicles may be parked on the main road. Over flow parking is available at bathrooms and Campground Office. No washing vehicles.
- Trailer tongues may not sit directly on the pavement

#### Parks Pass

• All vehicles are required to have a valid parks pass. Camping permits are sold separately.

#### **Handicapped Sites**

• Campsites designated with a "HD" are reserved for handicapped campers only. Handicap placard or plates must be visible. .

#### Littering

 Maintain a clean campsite. Food, cigarette butts, and trash are harmful to wildlife. Messy campsites attract unwanted wildlife interactions.

# Duration

- Camping is limited to 14 days in any 45 day period **Fires**
- Open-flame fires are permitted only in designated fire pits. Gas and propane grills are allowed.
  Gathering firewood in the Park is prohibited. Fire wood can be purchased in the Campground Office. Do not leave fires unattended. Completely extinguish fires when not in use.
- Obey mandatory fire restrictions when in effect.

# **Trees, Shrubs and Signs**

 Nothing may be hung on, from or attached in any way to trees, shrubs or any buildings or signs.
Hammocks and ropes tied to trees damage the tree.

#### **Maximum Occupancy**

• A maximum of 6 people, 2 camping units and two 2 vehicles are allowed per site. Camping unit is defined as a tent, camper or RV. Only 1 RV or camper is permitted per site.

#### **Handicapped Sites**

 Campsites designated with a "HD" are reserved for handicapped campers only. Handicap placard or plates must be visible.

#### Facilities

 All campground facilities are for registered campers only. All bathrooms will be closed daily for cleaning. Campers will not be permitted to utilize bathroom when closed.

#### **Motorized Scooter**

 No motorized scooters or kid cars are allowed in the campground or any road or trail in the Park.

#### Emergency

- **Call 911 or 303-795-4711** if you are experiencing an emergency. The Park Rangers will be notified through the emergency channels.
